Smith is a trilingual, Fulbright award-winning attorney with over a decade of on-the-ground experience working with, training, and advocating for persons with intellectual and other disabilities in the United States, Bangladesh, Mexico, and beyond. His Spanish, English, and Bangla language materials have shaped disability rights strategic litigation and important decisions by national and regional courts, and his disability rights scholarship has appeared in collections published by Cambridge University Press and Oxford University Press, as well as both U.S. and international law reviews. A lifelong advocate for his sister, who has Down syndrome, he has designed and implemented disability rights initiatives of increasing sophistication in the United States and abroad. He has trained and collaborated with local actors in English, Spanish, and Bangla to mount successful strategic litigation, as in *Chowkider v. Bangladesh Civil Service* which opened Bangladesh's civil service to blind persons for the first time, and to ensure that national and regional tribunals recognize the rights of persons with disabilities, such as the rights of prisoners with disabilities in the Inter-American Court of Human Rights' *Chinchilla Sandoval v. Guatemala* decision.
